Terms and Conditions

➤ Fees:

- Booth fee is a non-refundable* donation.
- Booth fees are due in full within ten (10) calendar days from the date of acceptance notification. **Please do not remit payment until you receive notification of application acceptance.** Fees not received by the deadline may result in the forfeiture of sponsorship placement.
- Refunds will NOT be given to Sponsors who do not show up for the event.
- Paw Partners Unleashed is not liable if weather or other conditions prevent Sponsors from attending and fulfilling the contractual obligation as a Sponsor. No refunds will be made for weather, accident, health, or other causes for non-participation.
*A refund will be made if the event is cancelled in advance, in its entirety, by Paw Partners Unleashed.
- Compliance with applicable state or federal tax laws is the responsibility of the Sponsor. Paw Partners Unleashed is not responsible for, nor do we collect sales tax; however, the State of Nevada Department of Revenue may require us to submit names and addresses of participating Sponsors. ➤ Space and Equipment:

- Sponsors are provided with a 10'x10' space (located outdoors), which includes an 8'x8' canopy, one 6-ft table, 2 chairs, and treats to pass out at the booth. Additional benefits can be located by sponsor level in the Sponsorship Benefits graphic. Electricity is NOT available for this event.
- Booth spaces will be assigned. Placement, flow, and competition will be taken into consideration to provide the best experience for attendees. If you have special space needs, please include your request with your application and we will make every effort to accommodate you. Booth spaces are reserved on a first come/first serve basis.
- Sponsors and Vendors must staff their own space.

➤ Setup/Break Down:

- All booths must be set up and ready for guests by 9:45 AM the day of the event. Participants may begin setting up at 8:00 AM the day of the event.
- Booths must be manned at all times and intact until the event closes at 4:00 PM. **No booth is to close or begin breaking down before the official closing time.**
- Sponsors agree to maintain cleanliness of their booths and must ensure the space is trash-free prior to leaving the event.
- Sponsors may unload/load vehicles near their booth location. **Refrain from blocking passing traffic.** Once unloaded, vehicles must be moved to the designated Sponsor/Vendor parking area to allow for event guests.
