Volunteer Release and Waiver of Liability

This Release and Waiver of Liability (the "Release"), executed on the date listed below by the individual whose signature appears below (the "Volunteer") releases Paw Partners Unleashed, Inc., a nonprofit corporation organized and existing under the laws of the State of Nevada, its directors, officers, agents, representatives, and sponsors (collectively, the "Released Parties").

The Volunteer desires to provide volunteer services for Paw Partners Unleashed (also referred as "PPU") and engage in activities related to serving as a volunteer. The Volunteer agrees to read and follow the policies and guidelines of the organization. Volunteer understands that services are provided strictly in a volunteer capacity and that no compensation or employment-related benefits are to be expected in return for services provided as a volunteer.

Please read and initial next to the Terms and Conditions below to confirm your understanding and agreement.

Release and Waiver: I hereby release, indemnify, and forever discharge and hold harmless the Released Parties and their successors and assigns from any and all liability claims, demands, costs and damages of any kind or nature, which I or my heirs, assigns, next of kin or legal representatives may have or which may hereinafter accrue, arise from, or are in any way related to my activities with any of the Released Parties, including but not limited to personal injury, bodily injury, illness, property damage, loss or death, whether caused wholly or in part by the simple negligence, fault or other misconduct of any of the Released Parties or of other volunteers, other than their intentional or grossly negligent conduct.

Assumption of Risk: I understand that services I provide to PPU may include activities that may be hazardous to me including, but not limited to interaction with people at events, driving, use of office equipment, lifting, moving items, occasional contact with third-party pets, etc. As I volunteer, I hereby knowingly assume the risk of injury, harm and loss from the activities and Release the Released Parties from all liability.

I understand that I have the right to refuse to perform any activity that I feel I am unqualified or unable to perform, or that I deem to be unsafe. I further agree to remove myself from any activity that I feel I cannot physically or mentally perform.

Medical Treatment: I hereby release and forever discharge the Released Parties from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment or other medical services rendered in connection with an emergency during my tenure as a volunteer with PPU.

Insurance: I understand that the Released Parties are under no obligation to provide, carry or maintain health, medical, auto, disability, or other insurance coverage for any volunteer. Each volunteer is expected and encouraged to obtain his or her own health, medical, auto, disability or other insurance coverage.

Photographic Release: I grant and convey to PPU all right, title, and interests in any and all photographs, images, video, or audio recordings of me or my likeness or voice made by PPU in connection with my providing volunteer services to PPU.

Other: I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Nevada and that this Release shall be governed by and interpreted in accordance with the laws of the State of Nevada. I agree that in the event that any clause or provision of this Release is deemed invalid, the enforceability of the remaining provisions of this Release shall not be affected.

I understand that this is not a contract of employment and that Paw Partners Unleashed has the right to terminate my services as a volunteer at any time, with or without notice, with or without reason. I also have the right to terminate my services as a volunteer at any time. Paw Partners Unleashed is not obligated to provide placement, nor are you obligated to accept the volunteer role offered.

Paw Partners Unleashed considers all applicants for placement without regard to race, color, national origin, sex, age, disability, religion, pregnancy, sexual orientation, genetic information, gender identity and expression.
